WHAT ARE BYLAWS?

Robert's Rules of Order Newly Revised (RONR), 12th edition, section 2.8 defines bylaws as the document of a society that contains its own basic rules relating principally to itself as an organization. The bylaws define the primary characteristics of the organization, prescribe how the society functions, and include all the rules that the society considers so important that they cannot be changed without previous notice and the vote of a large majority, and cannot be suspended.

WHAT THE GFWC BYLAWS COMMITTEE DOES

FROM THE GFWC BYLAWS

ARTICLE XII

Committees

Section 12.1 Standing Committees.

B) Bylaws. The Parliamentarian shall serve as an advisor to the committee. This Committee shall submit proposed amendments to the Bylaws for consideration at the GFWC annual convention, as provided in Article XVII. It shall consider amendments suggested by the Executive Committee. It shall also consider amendments that are proposed by the Board of Directors, Standing and Special Committees, or a State Federation, when submitted to the committee chairman by the first of November. It shall submit the proposed bylaws amendments to the Executive Committee for review. The committee may submit standing rules to the Executive Committee for consideration.

ARTICLE XVII

Amendments

These bylaws may be amended at any annual convention by a two-thirds vote of those present and voting, provided the proposed amendment has been appended to the call to the convention. Amendments of an emergency nature may be considered at annual convention without previous notice but require approval by a nine-tenths majority vote of those present and voting.

HOW AMENDMENTS TO THE GFWC BYLAWS ARE PROCESSED

State Federation and GFWC Committees, as well as the GFWC Executive Committee and Board of Directors, may propose amendments. Individual members, clubs, and GFWC Regions may not submit proposed amendments. Proposed amendments are submitted to the Bylaws Committee Chairman by NOVEMBER 1 of each year. The committee considers these proposals and submits a report to the GFWC Executive Committee at a meeting held in the year's first quarter (usually JANUARY). The proposed amendments are published in the Call to the GFWC Annual Convention (no later than APRIL 15). The amendments are presented at the Annual Convention (usually in JUNE), and action is taken. Those amendments approved by the delegates are then placed in the GFWC Bylaws, and an updated document is made available to the membership soon after the close of the convention.

When proposing an amendment, state the Article and any section or subsection where the amendment is to be made. State exactly what is to be amended, what is to be removed, added, or otherwise changed, and how the bylaw should read if the amendment is adopted. Give the reason why this change is proposed. If the proposal comes from a State Federation, include the pages of minutes of the meeting where this proposal was presented to the delegates and voted upon, along with verification by the state president and state recording secretary.
